

# 2023 MARRS Championship Rules

## Objective

The Mid-Atlantic Road Racing Series (MARRS) is a series of SCCA-sanctioned races held in the Mid-Atlantic area by the Washington DC Region, and co-hosted by the South Jersey Region. The WDCR conducts a points competition, by class, to determine and recognize drivers' overall success in the series. Championship and runner-up awards are presented to participants in each qualifying class. These rules are applicable to all classes running in MARRS races including national classes, regional classes and WDCR optional regional classes. MARRS stickers must be displayed on each side of the car and will be available at Summit Point and New Jersey Motorsports Park through Tech, Registration and on the grid. Heat races will be awarded points according to Section 4 paragraph A and feature races will be awarded points according to Section 4 paragraph B.

## 1. Competitor Defined

- A. A competitor is defined as someone who has paid the entry fee and turned a wheel on the course, either in qualifying or racing.

## 2. Competitor and Class Requirements to Receive MARRS Points

- A. For all races, points will be assigned based on finishing position within class.
- B. To be eligible for year-end class championship and runner-up awards, a class must have had a minimum of two (2) competitors (not limited to MARRS competitors), in at least five (5) of the scheduled weekends.
- C. To be eligible for year-end class championship and runner-up awards, a driver must turn a wheel in at least five (5) of the feature races in that class during the course of the season.
- D. A driver who is disqualified will not receive MARRS points for that race. However, a disqualified driver will be counted as a competitor provided the driver meets the definition of competitor.
- E. A driver whose vehicle is found to be "Non-compliant (NC)" with class technical specifications will not be awarded MARRS points for race sessions in which they were determined to be non-complaint.

## 3. MARRS Rules Compliance

All cars displaying MARRS stickers are subject to technical inspection during all MARRS events at the discretion of the chief steward after receiving input from the appropriate driver representative and tech chief. These inspections will be non-invasive or minimally-invasive, with no bond required. Drivers have the right to refuse to submit their cars to such an inspection, but will forfeit all MARRS points to date. This right to refuse an inspection specifically does not apply to normal GCR supported inspections which will be agreed upon by the Chief Steward and the Chief Scrutineer prior to the start of the event, where specific penalties are mandated for refusing an inspection. If a competitor accepts the inspection request and a violation is found, penalty decisions will be made by the Chief Steward.

## 4. Race Points Awards

Competitors in MARRS sanctioned events shall be awarded points for their finishing position as follows provided the class requirements in section 2 above are met.

### A. Heat Races:

- C. All heat races will be scored as such (per 4.A. above), except when a feature race is cancelled (for any reason); in the event a feature race is cancelled, the heat race will be scored as a feature race (per 4.B.).
- D. No points are awarded to competitors who are considered Non-compliant (NC), DQ, DNF or DNS per the GCR.

**5. Maximum Points**

- A. In the spirit of series competition, competitors may accumulate MARRS points from no more than seven (7) of the heat races and seven (7) of the feature races. Standings will be computed using each competitor’s best results; however, any heat or feature race in which that driver is disqualified is not awarded points due to disqualification or penalized for non-compliance and that result must contribute to their year-end total.
- B. Ties in the final points standings shall be resolved on the basis of each driver’s record of first place finishes; then if necessary second place finishes; then if necessary third place finishes; etc., using only the races included in calculating the final year end points for each driver as described in Section 5 paragraph A. If two (2) or more drivers have accumulated the same number of first place finishes, second place finishes, third place finishes, etc. in the races counted, then the winner shall be the driver who beats the most competitors in their class in one (1) of their first-place finishes. If in all of their first-place finishes there were the same number of competitors, they shall be considered tied for the position in the standings.

**6. Authority and Administration**

- A. The MARRS Championship is conducted under the direction of the Road Racing Committee (RRC) of the Washington DC Region of the SCCA. MARRS championship rules are set by the RRC prior to the first MARRS race of the year. The Director of Road Racing shall also be the MARRS Series Administrator for the purpose of representing the series to the NEDIV council and in business arrangements with additional co-hosting SCCA regions and other potential partners.
- B. Post-event results and current MARRS championship standings will be posted on <https://MARRSpoints.com/>. The Director of Road Racing (DRR) shall appoint a points-keeper prior to the start of the MARRS season. Any challenge or protest of the points for a race must be filed with the DRR within 30 days of the conclusion of each event. Upon receipt of a protest regarding MARRS championship points the MARRS points keeper and DRR will investigate and determine appropriate corrective actions.

**7. MARRS Championship Awards Presentation**

The MARRS season trophies will be presented at the Washington DC Region annual awards ceremony. It should also be noted that these points may be used in the determination of other region awards such as Rookie of the Year, Driver of the Year, etc.
